

Alicia M. Johnson selected as Executive Director of Legal Aid of Western Missouri



KANSAS CITY, Mo. – Legal Aid of Western Missouri has selected Alicia M. Johnson as its new Executive Director. Johnson assumed the role Aug. 18, 2021

Johnson first joined Legal Aid – a non-profit that provides free civil legal assistance to people who need it most and can afford it least – in 2010 and has served as the Deputy Executive Director for the past seven years. In the Deputy Executive Director role, Johnson oversaw the Central office move from the downtown Kansas City area into a more accessible client community. The move ensured that the organization continues to remain client-centered and client-driven.

“Alicia is a positive and thoughtful leader. Her warmth, collegial style, practical approach to problem-solving, and passion for leveraging the greater legal community to help people who need Legal Aid’s services has earned the esteem of

Johnson is a proud graduate of UMKC Law School and appreciates the incredible legal community in this area. Johnson started practice in bankruptcy law before moving into the public service sector.
